4 GENERAL ORDER RE: IMPLEMENTATION OF EMERGENCY RELIEF
5 AUTHORIZED PURSUANT TO GOVERNMENT CODE SECTION 68115 BY
6 CHAIR OF JUDICIAL COUNCIL

8 On November 10, 2020, the Chief Justice of California and Chair of the
9 Judicial Council ruled as follows:

10 Because of the COVID-19 pandemic, leading to health and safety
11 concerns resulting in substantial operational impediments, and the
12 proclamations of states of emergency by federal, state, and local
13 officials, it was determined on March 18, March 23, April 13, May
14 19, June 11, July 29, September 3, and October 13, 2020 that the
15 conditions described in Government Code section 68115 were met
16 with regard to the Superior Court of California, County of Merced
17 (Court). Based on those determinations, and pursuant to the Court's
18 requests, eight prior emergency orders issued, authorizing the Court to
19 implement certain relief under Government Code section 68115.
20 Upon the renewed request of Presiding Judge Donald J. Proietti, it is
21 determined that the conditions described in Government Code section
22 68115(a) continue to exist (Gov. Code, § 68115(c)), and it is ordered
23 that the Court is authorized to do the following:

- 24 1. Extend the time periods provided in sections 583.310 and 583.320 of
25 the Code of Civil Procedure to bring an action to trial by not more
26 than 30 days, applicable only to cases in which the deadline
27 otherwise would expire from January 1, 2021, to January 31, 2021,
28 inclusive (Gov. Code, § 68115(a)(6)); and
2. Extend the time period provided in section 1382 of the Penal Code
(section 1382) for the holding of a criminal trial by not more than 30
days, applicable only to cases in which the original or previously
extended statutory deadline otherwise would expire from November
16, 2020 to December 15, 2020, inclusive (Gov. Code, §
68115(a)(10); Executive Order N-38-20 (03-27-20)).

2 This authority supplements the authority to extend section 1382
3 deadlines previously granted in the March 23, March 30, and April 29,
4 2020 statewide emergency orders and in the May 19, June 11, July 29,
5 September 3, and October 13, 2020 emergency orders specific to the
6 Court. Accordingly, for any case in which the time to bring a
7 defendant to trial previously was extended under one or more of those
8 prior emergency orders, and the extended deadline falls within the
9 above-specified time period, this order authorizes the Court to extend
10 the previously extended deadline by up to an additional 30 days. For
11 any case in which the initial section 1382 deadline falls within the
12 above-specified time period and is not governed by a prior emergency
13 order, this order authorizes the Court to extend the time to bring a
14 defendant to trial by a total of up to 30 days.

15 Accordingly, the Presiding Judge of the Merced Superior Court, hereby
16 orders as follows:

17 The Judges of the Merced Superior Court are hereby authorized to:


- 18 1. Extend the time periods provided in sections 583.310 and 583.320
19 of the Code of Civil Procedure to bring an action to trial by not
20 more than 30 days, applicable only to cases in which the deadline
21 otherwise would expire from January 1, 2021, to January 31, 2021,
22 inclusive (Gov. Code, § 68115(a)(6)); and
- 23 2. Extend the time period provided in section 1382 of the Penal Code
24 (section 1382) for the holding of a criminal trial by not more than
25 30 days, applicable only to cases in which the original or
26 previously extended statutory deadline otherwise would expire
27 from November 16, 2020, to December 15, 2020, inclusive (Gov.
28 Code, § 68115(a)(10); Executive Order N-38-20 (03-27-20)).

29 This authority supplements the authority to extend section 1382
30 deadlines previously granted in the March 23, March 30, and
31 April 29, 2020 statewide emergency orders and in the May 19,
32 June 11, July 29, September 3, and October 13, 2020 emergency
33 orders specific to the Court. Accordingly, for any case in which
34 the time to bring a defendant to trial previously was extended

1 under one or more of those prior emergency orders, and the
2 extended deadline falls within the above-specified time period,
3 this order authorizes the Court to extend the previously extended
4 deadline by up to an additional 30 days. For any case in which
5 the initial section 1382 deadline falls within the above-specified
6 time period and is not governed by a prior emergency order, this
7 order authorizes the Court to extend the time to bring a defendant
8 to trial by a total of up to 30 days.

9 THIS ORDER IS EFFECTIVE IMMEDIATELY.
