22CV-01155 Estate of Devonea Graham, et al. v. County of Merced, et al.

Motion by California Public Utilities Commission for Judgement on the Pleadings

The Request for Judicial Notice by Defendant California Public Utilities Commission is GRANTED.

The Motion for Judgment on the Pleadings as to the First Cause of Action for Negligence is SUSTAINED WITH LEAVE TO AMEND. Plaintiff fails to name any employee of the California Public Utilities Commission or any specific act or omission by any such employee. Furthermore, the Second Cause of Action for Danerous Condition on Public Property confers statutory immunity to all employees with regard to their duties and responsibilities over public property. (Government Code § 840 ["public employee is not liable for any injury caused by a condition of public property where such condition excists because of any actor or omission of such employee within the scope of his employment"]; *Van Kempen v. Hayward Area Park, etc. Dist.* (1972) 23 Cal.App.3d 822, 825 [on claims invovlign public property only Government Code section 830 are controlling not Government Code section 815].)

The Motion for Judgment on the Pleadings as to the Second Cause of Action for Dangerous Condition on Public Property is SUSTAINED WITH LEAVE TO AMEND. Plaintiff has failed to state facts establishing that Defendant California Public Utilities Commission had ownership or control of the property where the incident occurred and matters of which this Court takes judicial notice establish that Defendant does not have ownership and does not have control. (*Goddard v. Dept. of Fish & Wildlife* (2015) 243 Cal.App.4th 350, 359.) Furthermore, mere regulatory control of crossings is not control for purposes of dangerous condition claims. (*Public Utilities Com. V. Superior Court* (2010) 181 Cal.App.4th 364, 366.)

While the opposition contends that, after considerable effort, Plaintiff obtained information that would support either the first or second cause of action, that information is not alleged in the subject complaint. Accordingly, the Motion for Judgemnt on the Pleadings is GRANTED WITH LEAVE TO AMEND.
