Motion to Dismiss by Defendant St. Louis Canal Company (Code Civ. Proc. § 583.210)

The unopposed motion to dismiss by defendant, St. Louis Canal Company, for failure to serve the summons and complaint within three years as required by Code of Civil Procedure section 583.210 is GRANTED.

Demurrer by Defendant St. Louis Canal Company

The unopposed demurrer is OVERRULED AS MOOT, the matter having been dismissed pursuant to Code of Civil Procedure section 583.210.

Demurrer by Defendant Midway Community Services District

On Friday, April 11, 2025, defendant Midway Community Services District filed a notice of demurrer and demurrer to the third amended complaint, with a hearing date of April 15, 2025. No proof of service was attached to the notice or demurrer, nor was a proof of service separately filed with the court.

Demurrers must be filed with adequate notice of hearing as prescribed by Code of Civil Procedure section 1005, subdivision (b). (Cal. Rules of Court, rule 3.1320, subd. (c).) The mere two court days of possible notice provided by defendant falls far short of the mandate that moving papers be filed and served no less than 16 court days before the hearing. (Code Civ. Proc. § 1005, subd. (b).)

Demurrers must also be filed within 30 days of service of the complaint that is the subject of the demurrer (Code Civ. Proc. § 430.40, subd. (a).) The demurrer to the third amended complaint – with a filing date of December 18, 2024 – was filed April 11, 2025.

Accordingly, the demurrer by defendant Midway Community Services District is OVERRULED as untimely, lacking sufficient notice, and without proof of service on the opposition.
