Motion to Compel Satisfaction of Judgment

The Motion to Compel Satisfaction of Judgment is DENIED. There is no dispute that there are a number of transactions between Pandit Samrah Singh and Bhupinder K. Sahota in which money or property or promises or other rights were transferred between parties, though there is considerable dispute as to the reasons for such transfers. What is not clear is whether the retention of the surplus sales proceeds of the California City Property transferred to Mandeep Sahota in August 2019 and the receipt of alleged option payments by Pandit Samrath Singh was transferred solely for the purpose of satisfying the judgment that the original Plaintiff in this action, Amarjit Kandola, assigned to Pandit Samrah Singh on or about January 25, 2024 (The written assignment was executed March 6, 2024 and filed with the Court on March 21, 2024. The fact that the proceeds were paid to Mandeep Sahota and Pandit Samrah Singh rather than to Amarjit Kandola, the then holder of the judgment, suggests that the transfers were not intended to satisfy that particular judgment because they were not paid to the person who had power to issue a satisfaction of judgment at the time such payment was made.

On or about January 25, 2024 (The written assignment was executed March 6, 2024 and filed with the Court on March 21, 2024), Pandit Samrah Singh Sahota paid the judgment in exchange for an assignment by the Judgment Creditor Amarjit Kandola. The payment of the Judgment by Pandit Samrah Singh Sahota would appear to render moot the issue of whether the surety document submitted to Amarjit Kandola by Bhupinder K. Sahota to stay execution was enforceable.
